DIRECTOR'S REPORT: Brittani Saunders

Brittani gave an update on our curbside report. For June we were at 47%. After the 4-H Fair, there were roughly 30 plus recycling bins dropped off at new homes so Brittani hopes for an increase for July or August.

EDUCATION REPORT: Brittani Saunders

Brittani was asked to be an educator for an Enviro camp in Rushville and Batesville. Due to time constraints Brittani was unable to get a camp started for Decatur County but hopes for next year. She would have a lot of help from fellow educators and directors for next year.

OLD BUSINESS: Brittani Saunders

In our previous meeting a property located by St. Mary's Catholic Church and owned by the church is going up for sale. Currently they are asking \$95,000 for this property that includes a block building and duplex. The land is currently paved and zoned as commercial. St. Mary's Catholic Church has agreed if we would go forward with purchasing that they would sign a purchase agreement allowing us to purchase when they move to their new location. Brittani would like the location for electronic collection, recycle drop off site, and more program space for the recycling district. The board has asked Brittani to go back to the owner and see about a formal proposal and negotiation on price. Brittani will come back at our next board meeting with more information.

NEW BUSINESS:

Matthew Lloyd currently at 5759 S Co Rd 100 W and Carl and Rosie Stier who currently live north of his property presented issues to the board. The previous owner of the property owned by Mr. Lloyd was Jimmy Colson. Mr. Colson was a former yard waste contract holder and he built and developed the property. From what Mr. Lloyd gathered, Mr. Colson constructed part of the driveway out of the yard waste from the City of Greensburg. Brittani was only able to find 2000 thru 2003 Contracts with Mr. Colson's name. Due to the past Directors retention schedule, we do not have any contracts before this time. Mr. Lloyd's driveway is failing and causing drainage issues that is affecting Carl and Rosie Stier's property as well. The yard waste would have been dumped well within 50 ft of the property lines and road. The damage has caused a large water hole that is not draining. There are also significant erosion issues. The contracts state that the City and District are not liable. However, the board has asked to go back to their attorney to go over the contracts and specifics to find out what can be done. The board has also asked Mr. Lloyd and Carl and Rosie Stier to receive several quotes on what it would cost to fix the current issues. This conversation will continue at our August meeting with more information being gathered.

Adam Leising with Leising Excavating and Mulching gave two options for extending their contract with a price of \$6,000 if they dispose of all trash. The second option is no cost to the district if the Solid Waste District would take back all trash and be responsible for disposal. Adam explained that they usually go through a 6 yd container every week. The board has asked for a more formal proposal at our next meeting. Once Brittani goes over our current contract documents with our Attorney, Drew Young, she will send out documents to Leising Excavating as well as Carl Stier.

OTHER COMMENT: Brittani let the board know that recycling was collected at the Tenderloin Throw down and she hopes to get in touch with St. Mary's and the president of the Fall Festival Board to offer recycling at their events coming up as well.

ADJOURN: Next board meeting July 28, 2015. Motion was made by John Richards to adjourn the meeting. Motion was seconded by Kenny Hooten.
