

**MINUTES OF THE DECATUR COUNTY  
SOLID WASTE MANAGEMENT BOARD**

The meeting of the Decatur County Solid Waste Management District Board was called to order by Chairman John Richards on Tuesday, October 25, 2016 at 6:00P.M. at the Decatur County Solid Waste Office at 315 S Ireland St, Greensburg, IN 47240

**APPROVAL OF MINUTES:** Darren Covington made a motion to approve September 2016 Minutes. Joyce Brindley seconded and the motion carried.

**APPROVAL OF CLAIMS:** Darren Covington made a motion to approve October 2016 Claims. Mayor Manus seconded and the motion carried.

**DIRECTORS REPORT:** Brittani Saunders

At our last board meeting, we had decided to enter into contract with NuGenesis for our sharps disposal. Before the contract was signed Brittani was in touch with Stericycle to cancel services. Stericycle did not inform us that our contract was automatically renewed in July. Due to this we would have to pay the remainder of our 3-year contract to get out of the current contract. Brittani was able to negotiate a 3-year contract of a price of \$670 plus taxes and fees with Stericycle. This is significantly lower than NuGenesis proposed amount of \$850.00. Stericycle has also agreed to remove the automatic renewal term in their contract if we should sign. NuGenesis is aware of what has happened and is understanding of the situation. Since we did not sign a contract with them we are not bound to Nugenesis' contract. Joyce Brindley made a motion to accept Stericycle's contract and Darren Covington seconded and the motion carried.

Brittani gave the board our 2016 Tox-a-Way Totals:

**OTHER COMMENT:**

Wendy Blake of Mainstreet Greensburg presented a downtown design program that will get under way next year. In this design, there is a need for trash/recycling containers around our downtown square. Currently many people are discarding trash and recyclables on the ground so the hope is with more trash and now added recycling that this will no longer be an issue in our Downtown. The cost of 11 recycling and trash containers is approximately \$7800.00. The board thinks it would be in our best interest to pay for this portion of the project because it is an important part of our mission in the county. Joyce Brindley asked if there was enough funding for this in our current budget and Brittani confirmed there would be enough for this. John Richards made a motion to pay for this portion of the project and Joyce Brindley seconded the motion. All in favor and the motion carried.
