DIRECTOR'S REPORT: Brittani Saunders

This year's fair went well and Brittani thanked everyone on the board for coming and helping work this year.

Allison Mitchel from Indiana Recycling Coalition came to the office to talk about what recycling efforts are taking place in Decatur County. IRC also wants to help local districts in their efforts and we should be hearing more from Allison in the coming months.

There will be a shredding day for the City and County offices on October 25th. Brittani has let officials at both locations know about this upcoming date.

Rick Nobbe and Brittani have talked with Chris Grabowski with Maxwell Construction on recycling for the jail project. Chris said there could be some recycling done, but it will depend on the contractor's ability to do so. Brittani will talk more with Chris as they get closer to starting construction to see if this would be a feasible option.

Brittani has plans for 2019 to start working closely with Decatur County Public Library on projects for the community. Rain barrel workshops and Composting workshops will more than likely take place in the spring of 2019 as scheduling for this Fall has been difficult.
